#### **1.2. INTRODUCTION**

KZNFILM is mandated to be a catalyst for transformation, job creation and sustainability through funding, human capital development and the promotion of KwaZulu-Natal. The economic impact of the film industry is principally experienced through job creation. Whilst the province is rich in history there is an apparent lack of converting such into scripts which in turn result in productions for the local, national and international market. There are a number of aspirant filmmakers in the province who require the necessary support in order to improve their skills to be that of an international standard.

#### **1.3. THE PURPOSE OF THE TERMS OF REFERENCE**

The KwaZulu Natal Film Commission (KZNFILM) is calling for the appointment of ten (10) suitably experienced producers to apply to serve on a Supervising Producer Panel for the KZN Film Fund projects. KZNFIIm will allocate supervising producers to Tier 3-5 funded production projects, to guide and oversee the implementation of projects.

## 2. Contract Objectives:

## Why is this Project Important?

This project aims to concretize the transformation goals of KZNFilm of ensuring rapid growth, and therefore transformation of the film and TV industry in the province by ensuring that skills are transferred between experienced producers (Tier 1-2), to entry level and emerging producers (Tier 3-5).

The Supervising Producer will:

- Guide, mentor and oversee the implementation of funded projects

- Provide guidance, mentorship and oversight on Special projects, award to Tier 3-5 producers and other inexperienced producers

- Is 100% sure that the final films can be completed before tranche 1 payments are released

- Ensure funding plans are in place, and funds are allocated correctly
- Oversee production budgets and schedules to ensure that delivery of a quality project
- Oversee contracting of talent, crew, cast, service providers, locations etc
- Be on location to oversee and view rushes
- Mitigate all risks

## 3. Scope of Work

The Supervising producer will:

- Guide, mentor and oversee the implementation of funded projects

- Provide guidance, mentorship and oversight on Special projects, award to Tier 3-5 producers and other inexperienced producers

- Is 100% sure that the final films can be completed before tranche 1 payments are released

- Ensure funding plans are in place, and funds are allocated correctly
- Oversee production budgets and schedules to ensure that delivery of a quality project
- Oversee contracting of talent, crew, cast, service providers, locations etc
- Be on location to oversee and view rushes

#### 4.1. Outputs and Deliverables

The supervising producers shall have:

- Proven experience in a similar role as a Producer on 1-2 feature films, documentaries, animation projects, and television series

- A detailed CV/resume detailing their experience for a period of 5-10 years as a producer

- A motivation letter that details a motivation for being considered as a member of the Supervising Producer Panel

- A mandate from a national filmmaker member body, no older than one month, that the applicant is a member of

#### 4.2 Team Composition:

- Analyst (KZNFilm)
- Producer (Contracted to KZNFilm)
- P&D Manager (KZNFilm)
- Production accountant (KZNFilm)
- Production Accountant (Contracted to Awarded filmmaker)
- One of the Supervising Producer Panel Members (10 in total)

#### 5.Logistics and Timing

#### **5.1 Duration of the Contract**

The period of execution of the contracts will commence from the date of signing the contract for a period of 3 years.

#### 5.2 Reporting

The service provider is required to report to the Acting P&D Manager: Mrs. Jacqueline Rainers-Setai on progress of the project within the stipulated timeframes. The reports will be required to be documented in a specific format as provided by the HCD Manager: Mrs. Jacqueline Rainers-Setai.

The service providers must avail themselves to status meetings as and when required on the progress of the project.

The acting Development and Production Manager: Mrs. Jacqueline Rainers-Setai will evaluate after each formal engagement before any payment is approved.

All meetings are to be arranged by KZNFilm who is expected to keep a record of such meetings and to deliver the record of a meeting within 5 working days of it having taken place. These meetings will be held at the offices of the KwaZulu-Natal Film Commission unless indicated otherwise. Failure to comply with the conditions may result in termination of the contract.

### 6. Tender Requirements

## 6.2. Project Proposal

The project proposal will contain both the Technical and Financial Proposals. Each section will be broken down as follows:

## 6.2.1. Technical Proposal Requirements

- Proven experience in a similar role as a Producer on 1-2 feature films, documentaries, animation projects, and television series

- A detailed CV/resume detailing their experience for a period of 5-10 years as a producer

- A motivation letter that details a motivation for being considered as a member of the Supervising Producer Panel

- A mandate from a national filmmaker member body, no older than one month, of which the applicant is a member

### 6.2.2. Rates

- R10 000 per month for a maximum of 4 months per project

- Travel, accommodation, meals to be covered by the awarded producer
- Inclusive of VAT
- The Supervising Producers will be rotated based cost and availability.

- Servicing as a supervising producer: R10 000 per month for a maximum of 4 months per project.

## 7. Evaluation Criteria

#### Specific Goals will be applicable for this Quotation process.

The bid for the appointment of each service provider will be evaluated on mandatory requirement, functionality, preference point system and specific goals in accordance with the Preferential Procurement Regulation 2022.

## Mandatory Requirements (If applicable) (disqualifying requirement)

A mandate from a national filmmaker member body, no older than one month, that the applicant is a member of, for example, SASFED, IPO, KZN FILM HUB, KZN FILM FEDERATION, BLACK FILMMAKERS ASSOCIATION, WRITERS GUILD SOUTH AFRICA, SWIFT, or an international organisation

#### **Evaluation of Functionality**

• The service provider must score a minimum of 60 % in order to be evaluated further for price and preference points. *Refer to Annexure 1* below, for the information that must be provided and supported with documentation in order for the bid proposal to be evaluated and scored on Functionality.

#### APPLICATION OF PREFERENCE POINT SYSTEM AND SPECIFIC GOALS:

The 80/20 preference points system will be applicable for the evaluation of this process in accordance with the Preferential Procurement Regulations 2022.

Points for price (80) will be R160 000 for supervising producer panel members, since this is a standard rate
